Dear Shri Bam

You will be pleased to know that the Rajiv Gandhi University Bill, 2006, aiming at conversion of Rajiv Gandhi University into a Central University, has been passed by both Houses of Parliament during the just concluded Winter Session, 2006. We propose to bring the Act into force immediately after assent of the President to the aforesaid Bill. Rajiv Gandhi University would, therefore, become a Central University very soon.

2. Under the relevant provisions of the Central Act, the Vice-Chancellor appointed under the provisions of the State Act shall hold office for a period of three months or till such time the first Vice-Chancellor is appointed under the Central Act, whichever is earlier. Now that the University is becoming a Central University, the Central Government as well as the University Grants Commission, through which the funding of the University is to be routed, expects that the University, during this interim period, will avoid any major policy decision or such decision(s) as may have long-term financial implications. While I am endorsing a copy of this letter to the Vice-Chancellor, you may also like to issue necessary advisory to the University under intimation to this Ministry.


